## Gallery Policies and Information

The Gallery is open and tended by Great Atlantic Management every day, **Monday to Friday from 9:00 a.m. to 1:00 p.m. and 2:00 p.m. to 5:00 p.m.** **Free coffee is available daily.**

1. An impartial juror will jury participants' artworks for show entry. We accept two-dimensional and some three-dimensional original art; there are no other restrictions on medium or format, a **minimum of 6 and a maximum of 10** works per artist. The entry fee is **\$20**.
2. Two-dimensional works must be framed and ready for hanging with hook eyes and wire. **NO SAWTOOTH HANGERS OR WET PAINT WILL BE ACCEPTED.** Watercolors, pastels, drawings, or collages will not be accepted if not placed under glass or plexiglass. New watercolor canvas may be hung without glass.
  - Each painting must be identified by a sticker with the artist's name, title of work, medium, and price placed on the back or underside of each work of art.
  - Provide entry labels – business-size blank cards (white cards with **Arial Black** or similar font **size 18** or bigger – NOT handwritten) with name of the painting, artist, media, and price.
  - Provide a master list of works submitted with titles of paintings/objects and prices when you deliver them.
3. All paintings must be **for sale and remain** for the duration of the show unless sold. When a painting or art object is sold and removed, the artist must **replace it** with a comparable work as soon as possible and be responsible for a **corrected show list**.
4. **Sales and commissions:** When a work is sold, the buyer will make the check out to **Pembroke 4 Art Galley**, including tax. (Artist is responsible for paying sales tax.) Every two weeks Pembroke 4 Art Gallery will pay the 15% commission divided accordingly: 10% goes to Great Atlantic Property Management and the other 5% to Pembroke 4 Art Gallery.

Please submit copies of your Artist's Statement with a short bio and photo for availability at the opening reception and the duration of the show, plus your promotional cards or brochures. Postcards and/or flyers will be sent out to a Gallery list. However, the success of the show depends mainly upon the artists' spreading the word to their personal networks. Prepare your own e-mail or mailing list and send out personal invitations for the opening reception about two weeks in advance.

You will receive about 8 postcards. The flyer and postcards should arrive before July 1, 2010 . If they are not there, call to inquire.

Hanging date: Wed. April 21, 2010 Time 10 a.m.-noon

Opening reception: Fri. April 23, 2010 Time: 7:00 to 9:00p.m.

Pick up date: Monday, July 19, 2010 Time: 10am to noon

The juror will be looking for your adherence to “**the theme**” as well as the usual high standards of artistic expression. Your presentation should facilitate the viewer’s connection to the theme.

**---Directions to Pembroke 4 Art Gallery for you and friends. Include directions in your invitations but revise to suit your particular location: Take I264 to the PEMBROKE Independence Exit and move into a center lane on Independence Blvd. going north. After crossing Virginia Beach Blvd., move into the far left lane and turn left on Broad Street (across Independence Blvd. from Pembroke Mall). The Pembroke 4 Building will be on your left and is set back from the street. The Pembroke Office Center buildings are numbered; the gallery is on the ground floor of #4—the left corner space. There is a large parking lot directly in front.**

**---From I64, take the Virginia Beach Exit to get to I264. Then follow the directions above.**
